

NOTICE OF FORECLOSURE SALE

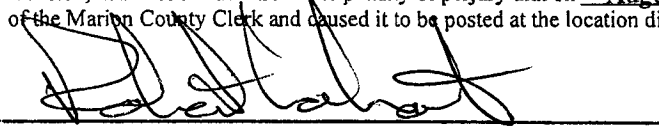
